- Policy on 13<sup>th</sup> month salary, implementation email coming from Natalie.
- Countries of concern: FL legislature passed a law related to country of domicile. Rule is that we cannot hire/employ, collaborate, or share data with anyone that is currently residing in a country of concern.
- Update from UF legal is that going forward from the time of the implementation of the rule, partnerships or collaborations with countries of concern that will lead to a publication, you need to obtain permission to enter into this collaboration. Also, there are potential restrictions on sponsor-paid travel, honorarium, etc. and reimbursements to countries of concern. It is important to ask in advance if you have questions or concerns, as this is a state law.
